**CONSENT**

**HOLD HARMLESS**

It is my express intent that this release and hold harmless agreement shall bind the members of my family and spouse (if any), if I am alive, and my heirs assigns and personal representatives, if I am not alive, shall be deemed as a release, waiver, discharge and covenant not to sue the Church. I hereby further agree that this waiver of liability and hold harmless agreement shall be construed in accordance with the laws of the state of Oklahoma.
